Section I, Definition of Terms:

For the purposes of this document, the following terms shall be used:

PR CON 2011 also referred to as a “computer gaming event” or a “LAN Party”.

The term “Hosts” includes, but is not limited to the Sponsors, Event Staff, Event Site personnel, and other persons.

For and in consideration of permission to participate in PR CON 2011, I hereby irrevocably and forever release, discharge, waive and hold harmless the PR CON 2011 and its officers, directors, employees, sponsors, facilities providers and agents (collectively referred to as “the hosts”) from any and all claims, losses, causes of action and liabilities of any kind (including legal fees) arising out of or relating in any way to the PR CON 2011. I voluntarily waive any claims that I might have against the hosts, and I understand and agree that the hosts assume no responsibility or liability for any injury to persons or property (including property that is lost, stolen or damaged), that may occur during PR CON 2011. I agree that I have read and will follow all official rules which are posted on the website and at PR CON 2011. I further agree that during PR CON 2011 I shall conduct myself in an appropriate fashion, under direction of the PR CON 2011 Staff and I shall not behave poorly by violating rules, performing harmful acts, using profanity, obscenity or any otherwise objectionable conduct towards any person or property involved with PR CON 2011. I recognize and understand that the hosts reserve the right to require cessation of any such activity and the hosts, in their sole discretion, may require my removal from PR CON 2011, **without any refund of any kind**. PARTICIPATION GUIDELINES:

- Participants WILL conduct themselves in a professional and sportsmanlike manner.
- Participants will be respectful of each other's person and equipment.
- Failure to follow these guidelines will result in immediate disqualification.
- Participants must not bring liquids into the area where the pc's are set up. Sports capped bottled may be excepted if they are checked by a team member prior to entering the pc area. The Project Reality team reserves the right to change this rule as they see fit and may restrict all fluids to a designated drinking zone.

CHEATING:

The Project Reality team has a zero tolerance for cheating! If you are caught using any of the following cheats but not limited to: cheat codes, exploits, debug version game kernels or libraries, excessive ping of network devices or computers to slow network bandwidth. If you are caught cheating during any tournament match, it will result in the forfeiture of the game, and disqualification from all remaining tournaments/games and removal from the site. Dev hacks are allowed.

ACTS OF VIOLENCE:

Acts of violence will NOT be tolerated! Intentional damage to property, other guest's computers, staff property, network equipment, and items belonging to sponsors, is grounds for immediate removal from the event **without refund**. The PR CON 2011 Staff reserve the sole right to define what is and what is not a violent act, and will use appropriate action to affect your removal from the premises if deemed necessary.

ILLEGAL ACTIVITIES:

The Project Reality team does not, under any circumstances condone any type of illegal activity whatsoever, including but not limited to the copying/sharing of illegal software, MP3's or distribution of pornographic material to minors. Anyone found to be partaking in these actions will be removed from the event **without refund** The Project Reality team do not condone pirating; however we cannot and will not police machines and network traffic trying to find such items. Each individual is solely responsible for the software/files and the copyright laws associated with items that are located on their machine. Participants understands that his/her machines(s) are his/her personal responsibility and liability and agrees to indemnify, defend and hold harmless Project

Reality/Staff/Hosts/Sponsors and each Sponsor's directors, officers, employees, agents and representatives from any claims arising out of, in whole or in part, the participant's use in any way of his/her computers, monitor, or other computer related equipment during any Project Reality LAN Party. Illegal substances and/or weapons of any kind are strictly prohibited. Anyone found in possession of these items will be removed from the event **without refund**.

ALCOHOL CONSUMPTION:

Alcohol may only be consumed on the evening of Saturday 17th September 2011 from 21:00 to 07:00 on Sunday 18th September and only in the designated drinking area. No alcohol will be purchasable at the venue. The PR CON 2011 Staff reserve the right to change these time restrictions at any point. If you are irresponsible in your alcohol intake, the PR CON 2011 Staff reserve the right to limit or remove your alcohol temporarily. If you are in a dangerous state or continue to be a hindrance or a danger to yourself or others due to alcohol, you will be removed from the premises **without refund**.

HACKING:

We do not tolerate hacking of any kind under any circumstance. Hacking of computers, network devices, DoS attacks, viruses, backdoors or anything of the sort is grounds for immediate dismissal from PR CON 2011 **without refund** and will lead to banning said player from all future events and the website.

OFFICIALS:

Project Reality officials along with Sponsors execute all facets of the LAN Party and Tournament. Project Reality Officials, the hosts and the sponsors reserve the right to require any Participant to replay any match for any reason, at their sole discretion and to disqualify any participant who fails to follow the Official Rules, who makes any misrepresentation relative to the Tournament and/or the redemption of prizes, who tampers with the entry process or the operation of the Tournament or Web Site, who acts in violation of the Official Rules, who acts in an unsportsmanlike or disruptive manner or who acts with intent to annoy, abuse, threaten or harass any other person(s). To ensure that players have played according to the Official Rules, Tournament Officials will review ALL game play during the Tournament. Decisions by Tournament officials are FINAL. All prize winners will be identified on site at the Event. A list of official staff members will be made available soon.

LIMITATION OF LIABILITY:

Sponsors and/or Project Reality officials are not responsible for any inaccurate information, whether caused by the Official Web Site or by the Web Site users or by any of the equipment or programming associated with or utilized in the event or the Tournament or by any technical or human error which may occur in the processing of Tournament results. Project Reality Administrators/Sponsors/Officials including Richard Russell assume NO liability for any injury, loss, or damage of any kind arising from or in connection with any person's participation in the Event or Tournament, including without limitation, participation in any real life activity, or injury, loss or damage sustained from use of any prize won.
